The College is situated on 300 acres of rural land, approximately 5 kilometers northeast of Aylmer and 190 kilometers west of Toronto and 210 kilometers east of Detroit/Windsor. It is about 40 minutes from London International Airport and 2 hours from Toronto's Pearson International Airport. Directions: Take Highway 401 to Imperial Road (Hwy. 73) (Aylmer Exit); proceed south through the villages of Mossley, Harrietsville and Lyons; turn east (left) onto Ron McNeil Line (County Rd. 52); turn south (right) onto Hacienda Road (County Rd. 32); turn left onto College grounds.
